The College of Law opened its doors in 1895 in rented downtown Syracuse office space with an entering class of just 23 students. By 1921, enrollment had climbed to more than 200 students and the College of Law moved into the John Crouse Mansion near the Syracuse University campus.

Over the years, the College of Law has graduated many influential and successful lawyers, business professionals, and financial leaders. We are proud to count among our alumni members of the U.S. Senate and Congress, state senators and assembly members, state attorneys general, and federal and state judges. In addition, many of our alumni have moved into leadership positions in some of the world's largest law firms and into the fields of finance, real estate development, and international business affairs.

Today, with an enrollment of more than 650 men and women from 28 states and 15 countries, the College of Law offers students an exciting and rigorous academic journey that provides the knowledge, discipline, and analytical skills needed to succeed in the legal profession and related fields—preparing the next generation of leaders to meet the demands and maximize the opportunities of our complex global society.

A DYNAMIC SCHOOL

The quality of College of Law students and faculty enhances our reputation within the national legal community. Our entering law students meet the highest academic standards and possess the drive and imagination needed to embrace the breadth of our interdisciplinary initiatives. Since 2002, we have added 17 new faculty members with J.D./Ph.D. degrees from some of the most prestigious colleges and universities in the nation. These new faculty members—along with an already well-recognized faculty base—are committed teachers and scholars who have a direct impact on the local community, in the national arena, and around the world.

Interdisciplinary programs at the College of Law exemplify Scholarship in Action—partnering with other schools and colleges to create innovative initiatives that cross academic barriers. Two institutes that have garnered significant attention on issues of great national and international importance include:

- >> The Institute for National Security and Counterterrorism (INSCT)—
 created in partnership with the Maxwell School—provides a systematic,
 interdisciplinary approach to important questions of law and policy
 related to national and international security and counterterrorism.
- >> The Institute for the Study of the Judiciary, Politics, and the Media (IJPM)—created jointly by the College of Law, the Maxwell School, and the Newhouse School—is a first-of-its-kind academic institute devoted to the interdisciplinary study of issues at the intersection of law, politics, and the media.
